1. Discussion and approval of October 2019 meeting minutes (Hays-Gilpin)

2. Update on AZSITE Administrator position (Watson)

Gabe McGowan has been hired for the manager position. Barring any delays in HR processing his employment, his start date is scheduled for January 6th. McGowan brings considerable technical skills to the position. The ASM has also hired a database manager for collections. Eventually, the two will work together to improve database management for both ASM and AZSITE.

3. Discuss acknowledgment of letter from the Governor's Archaeology Advisory Commission rec'd Dec. 6, 2019

The board members agree to craft a response to the letter rec'd from GAAC. Hays-Gilpin will draft the overall response including appreciation for the thoughtful and detailed communication, commitment to move forward with discussions of the programmatic agreement and executive order with the governor's office, commitment to working with GAAC on the question of the AZSITE Advisory Committee, and commitment to developing performance expectations and benchmarks for the AZSITE manger position. As part of this effort, the Board will encourage the new manager to hire an assistant. Watson will draft responses to several points raised about ASM and ARO. Motion to draft, circulate, finalize,

and submit a response letter. Motion by Watson, second by Powell. Motion carried unanimously.

4. Other items discussed—history of AZSITE manager position and state Human Resources processes; history of Advisory Committee meetings. Reviewed text of the Executive Order and verified that it states that AZSITE is the state's inventory, not the Archaeological Records Office—we recognize this as problem to be addressed in the coming year. Also flagged for future action in context of working with Governor's office, GAAC, Advisory Committee: role and function of the Museum of Northern Arizona's seat on the AZSITE Board; addressing backlog and accuracy of records; updating roles, responsibilities, configuration, communication of current members and additional stakeholders.
