- AZSITE Financial Report BPZ; copy of report made available prior to meeting
 - o As of 3/31/2013 AZSITE had \$~67,000K
 - o Includes Computer Purchase and RK travel expenses
 - o Not yet encumbered: \$29K for ASU/Jana for new server/website consolidation
- Standing report from AZSITE Advisory Committee (AS)
 - No comments
 - o See minutes from 1/17/2013 on file at ASM
- WAPA, COP, NPS updates (projects to correct data on these lands and provide to agencies)
 - WAPA final contracting, considered "Goods and Services" so only 9% will be snatched up by University (as opposed to 51%).
 - \$37K...then \$11K/year for 5 years
 - o COP Phase I complete. Additional \$24K over 5 years
 - Data verified/online already
 - Next: consolidate all site numbers as appropriate
 - Put boundaries online for all sites, even if no attribute data
 - NPS No headway at this point. Don't want to pay above and beyond Azsite membership fee for us to handle their work.
 - RK meeting with National NPS people soon at Cultural Resources Data Sharing Project, may make headway there
 - o NRCS templates reviewed...still figuring out financial aspect and logistics
- ISSR Ayan/Shay etc. Front end consolidation/single log-in
 - Updating attribute search
 - Will add document hook to find reports online (with Ok from our office), phasing out
 FTP site
- AZSITE tribal lands policy
 - o All projects crossing tribal land have been removed from system
 - Created checks to ensure none accidentally get added in future
- Discussion on maintaining webinar option for another year cost of \$900
 - Motion JC moved to continue the webinar
 - o 2nd by BPZ
