Financial report (Grindell):

Standing report from AZSITE Advisory committee (presented by member of public/outgoing Advisory committee chair, Alan Dart):

- A quorum was obtained
- Barnaby Lewis elected and 2015 chair
- At meeting there was a discussion of AZSITE application form "stipulations" presented by Al Dart. Will be discussed further at next meeting. Summary:
 - Current wording (item 4 of application) states (in summary) that AZSITE User application on individual workstations must be protected by firewall. Problem Government computers have varying security issues which may make firewalls impossible. Suggestion to re-word application to accommodate for that situation.
 - Current wording regarding the requirement of deleting AZSITE data upon end of user agreement – suggestion to re-word for clarity (such as they must delete database data, but keeping PDFs is ok?)
 - o Citation of National Historic Preservation Act needs to be updated per recent change to law

AZSITE Backlog status (presented by member of public Rick Karl):

- Negative surveys: current within approximately two weeks of proper data submission
- New sites: Approximate 1 year backlog
- Sites with updates: Approximate 2 year backlog
- WAPA/COP data updated within 30 days of proper data submission
- "New Site Number" layer is active on AZSITE, so researchers know any new site numbers requested in any given location within 30 days of request

• Part of backlog is due to problematic data submissions by contractors. They will be reminded that QA/QC is their responsibility. We have been doing it in order to get the most accurate data possible into AZSITE, but it is quite time consuming.

Large data set requests (presented by member of public Rick Karl):

- Proposed guidelines have been developed by R. Karl. Will be emailed to board for discussion at next meeting
- Rick Karl: SHPO recommendation to do AZSITE search prior to fieldwork recommended, not required. Only requirement is that report standards are followed.
